

**OFFICIAL RULES**

**ON-LINE PRIZE DRAWS**

1. **ELIGIBILITY:** This “Columbia Members Exclusive outdoor adventure week-end” On-Line Prize Draw is open only to individuals who (a) are legal residents of Great Britain or France, or Germany or Italy or Spain, or The Netherlands or Belgium, or Austria, or Ireland, or Finland (b) are at least eighteen (18) years of age at the time of entry, (c) have access to the internet and a valid e-mail address,(d) are a member of the Columbia UNLOCK membership program (i.e. having created an account on the [Columbia website](#)) and (e) have comprehensive travel and activity insurance and (f) are the holder of a valid passport and, if required, a valid visa permitting travel to the Event location. Employees or contractors of Sponsor, a competitor of Sponsor, or any of their affiliate companies, subsidiaries, agents, distributors, wholesalers, retailers, or advertising and promotional agencies, as well as the spouse, parents, siblings, children and household members of any such employee or contractor, are not eligible. This On-Line Prize Draw is subject to the laws of The Netherlands.
2. The Event involves physically demanding activities, including a two-day guided hike with an overnight bivouac in a mountain environment. By entering this On-Line Prize Draw, each participant confirms that they are in good physical health and have a level of fitness sufficient to participate in such activities. Winners may be required to complete a health and fitness self-declaration form prior to the Event. The Sponsor reserves the right to exclude any winner from specific Event activities if, in the reasonable opinion of the Event organizers or guides, participation would pose a risk to that individual's health or safety.
3. **SPONSOR:** This On-Line Prize Draw is sponsored by the Columbia Sportswear brand, represented by **Columbia Sportswear Company Limited**, 20 Oldfield Court, Windermere, LA23 2HJ, United Kingdom, Registration no 3854251 (“Sponsor”).
4. **AGREEMENT TO OFFICIAL RULES:** Participation in this On-Line Prize Draw constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor, which are final and binding.
5. **ENTRY PERIOD; PRIZE:** This On-Line Prize Draw begins on July 7<sup>th</sup> 2026 at 8am CET and ends on July 14<sup>th</sup> 2026 at 11.59pm CET (the “Entry Period”). Twelve (12) participants among all eligible entries received will win:
  - 1 (one) Outdoor train to hike week-end (“Event”) from [September 3<sup>rd</sup>] to [September 6<sup>th</sup>] 2026 including:
    - Return flight from the local international airport to London, UK and taxis shuttle to accommodation (economy class)
    - Friday and Sunday Caledonia train sleeper tickets, in double cabin accommodation
    - All meals from Friday dinner to Monday breakfast
    - A fully organized and supervised two-day guided hike, including an overnight bivouac from Saturday to Sunday (bivouac equipment — tent, sleeping mat and sleeping bag — can be provided free of charge. If a sleeping bag is borrowed, , a silk liner (also known as a sleeping bag liner) will be required, not included).
    - Presentation of Columbia equipment
    - One (1) Columbia welcome pack

The approximate retail value of the prize is £2000 per person.

The following is not included:

- Any additional meals and drinks.
- Participant's insurance
- any other costs, fees, and expenses not listed above
- sleeping bag liner
- transportation to and from your closest airport to take the flight to and from London
- fees for any VISA, if required

The 12 winners will be drawn at random from all participants who have registered via the online prize-draw site listed below. There is a limit of one prize per person. Prizes are nontransferable until awarded and are non-refundable. Within twenty-four (24) hours following the conclusion of the Entry Period, an independent party will draw the potential winners from among all eligible entries. Sponsor's decision is final and no correspondence will be entered into. Sponsor will notify each potential winner by e-mail within two (2) days. In the event of any dispute or ambiguity as to the identity/name of the person who may have submitted a particular entry, an entry will be deemed to have been submitted by the Authorized Account Holder of the username or e-mail address submitted at the time such entry is submitted. "Authorized Account Holder" means the natural person who is assigned to a particular username or e-mail address by an internet access provider, service provider, or other organization that is responsible for assigning e-mail addresses or usernames under the domain associated with the submitted e-mail address or username.
